

**PLEASE READ CAREFULLY BEFORE USING THIS PRODUCT:** This End-User License Agreement ("EULA") is a legal agreement between (a) you (either an individual or a single business entity) and (b) Visual Horizons Software, LLC ("VHS") that governs your use of the ConsignPro Software Product ("ConsignPro"). Other software provided by third parties and used with ConsignPro may be subject to a separate EULA. The term "ConsignPro Software Product" means computer software and may include associated media, printed materials and "online" or electronic documentation. An amendment or addendum to this EULA may accompany ConsignPro.

**BY CLICKING "I AGREE", OR OTHERWISE TAKING ANY STEP TO INSTALL OR USE CONSIGNPRO, YOU AGREE TO BE BOUND BY THE TERMS OF THIS EULA. YOU ALSO ACCEPT THIS EULA IF YOU KEEP CONSIGNPRO FOR 30 DAYS. IF YOU DO NOT ACCEPT THESE LICENSE TERMS, YOUR SOLE REMEDY IS TO RETURN THE ENTIRE CONSIGNPRO SOFTWARE PRODUCT (HARDWARE AND SOFTWARE) TO VISUAL HORIZONS SOFTWARE, LLC WITHIN 30 DAYS FOR A FULL REFUND SUBJECT TO THE REFUND POLICY OF VISUAL HORIZONS SOFTWARE, LLC.**

### **1. GRANT OF LICENSE.**

VHS grants you the following non-exclusive rights provided you agree to and comply with all terms and conditions of this EULA:

- a.) Use. You may use ConsignPro on a single computer at one time ("Your Computer") at the business you identify at the time of purchase. The use of the ConsignPro on multiple computers within the physical space of your business requires the purchase of a "ConsignPro network license" for each additional computer you intend to run ConsignPro Software on. The use of a single "home copy" of ConsignPro, by the licensee only, is permitted under this license and is governed by the terms of this EULA. You do not have the right to distribute the ConsignPro to any other party.
- b) Closure of Business. Should you close your business, the ConsignPro software license, and all network licenses, expires immediately and you forfeit all future rights to use ConsignPro and title to the license(s).
- c) Sale of Business. See TRANSFER below.
- d) Reservation of Rights. The ConsignPro Software Product is licensed, not sold, to you by VHS. VHS own all right, title and interest in and to ConsignPro and reserve all rights not expressly granted to you in this EULA. You agree to refrain from any action that would diminish such rights or would call them into question.

### **2. UPGRADES.**

To use a ConsignPro Software Product identified as an upgrade, you must first be licensed for the original Software Product identified by VHS as eligible for the upgrade.

### **3. ADDITIONAL SOFTWARE.**

This EULA applies to updates or supplements to the original ConsignPro Software Product provided by VHS unless VHS provides other terms along with the update or supplement. In case of a conflict between such terms, the other terms will prevail. This includes, but is not limited to, the use of the MyResaleWeb.com, Remote Data Loader, and Online Store Builder web services.

#### **4. TRANSFER.**

- a.) Conditions. Should you elect to sell your business, to a buyer (third party) who moves into your physical storefront and assumes the existing store name and phone number, this license can be transferred, single time, to the new owner. Applicable transfer fees and Support Plan fees apply on the date of the transfer and must be paid within 30-days of the transfer. Should that not occur, the ConsignPro license is voided and the new owner would be responsible for the cost of a new license or must discontinue the use of ConsignPro immediately. In such case, this license can only be transferred a single time.
- b.) Third Party. Any transfer must include all component parts, media, printed materials and this EULA. The transfer may not be an indirect transfer, such as a consignment. Prior to the transfer, the end user receiving the transferred product must agree to all the EULA terms. Upon transfer of the ConsignPro license, your rights to the license are terminated immediately.
- c.) Restrictions. You may not sublicense, assign, donate, or transfer the license of ConsignPro to any other third-party or end-user without the express written consent of VHS.
- d.) Business Liquidation or Closure. This ConsignPro license may not be transferred or sold as part of a business “liquidation or sale of assets” to any third-party. Refer to “Closure of Business” in 1b of this EULA.
- e.) Right of Final Determination. VHS reserves the right to determine whether any license meets our transfer criteria. Should information provided as part of a valid transfer later determined to be false, VHS reserves the right, at its sole discretion, to void ConsignPro license immediately. In such case, any and all transfer costs are non-refundable.

#### **5. PROPRIETARY RIGHTS.**

All intellectual property rights in ConsignPro and user documentation are owned by VHS and are protected by law, including but not limited to United States copyright, trade secret, and trademark law, as well as other applicable laws and international treaty provisions. The structure, organization and code of ConsignPro are the valuable trade secrets and confidential information of VHS. You shall not remove any product identification, copyright notices or proprietary restrictions from ConsignPro.

#### **6. LIMITATION ON REVERSE ENGINEERING.**

You may not reverse engineer, decompile, disassemble or create derivative works of ConsignPro, except and only to the extent that the right to do so is mandated under applicable law. Nothing contained herein shall be construed, expressly or implicitly, as transferring any right, license or title to you other than those explicitly granted under this EULA. Unauthorized copying of ConsignPro or failure to comply with the above restrictions will result in automatic termination of this Agreement and will constitute immediate, irreparable harm to VHS for which monetary damages would be an inadequate remedy, in which case injunctive relief will be an appropriate remedy for such breach.

#### **7. TERM.**

This EULA is effective unless terminated or rejected. This EULA will also terminate upon conditions set forth elsewhere in this EULA or if you fail to comply with any term or condition of this EULA.

**8. CONSENT TO USE OF DATA.** You agree that VHS and its affiliates or suppliers may collect and use technical information you provide in relation to support services related to ConsignPro. VHS and its suppliers agree not to use this information in a form that personally identifies you except to the extent necessary to provide such services.

**9. DISCLAIMER OF WARRANTIES.** ConsignPro is offered on an "AS-IS" basis and VHS does NOT warrant that the functions contained in ConsignPro will meet your requirements or that the operation of ConsignPro will be uninterrupted or error free. Computer software is inherently subject to bugs and potential incompatibility with other computer software and hardware. You should not use ConsignPro for any applications in which failure could cause any significant damage or injury to persons or tangible or intangible property. **TO THE MAXIMUM EXTENT PERMITTED BY APPLICABLE LAW, VHS AND ITS SUPPLIERS PROVIDE CONSIGNPRO "AS IS" AND WITH ALL FAULTS, AND HEREBY DISCLAIM ALL OTHER WARRANTIES AND CONDITIONS, EITHER EXPRESS, IMPLIED, OR STATUTORY, INCLUDING, BUT NOT LIMITED TO, WARRANTIES OF TITLE AND NON-INFRINGEMENT, ANY IMPLIED WARRANTIES, DUTIES OR CONDITIONS OF MERCHANTABILITY, OF FITNESS FOR A PARTICULAR PURPOSE, AND OF LACK OF VIRUSES ALL WITH REGARD TO CONSIGNPRO. NO ORAL OR WRITTEN INFORMATION OR ADVICE GIVEN BY VHS OR A VHS AUTHORIZED REPRESENTATIVE SHALL CREATE A WARRANTY.** Some states/jurisdictions do not allow exclusion of implied warranties or limitations on the duration of implied warranties, so the above disclaimer may not apply to you in its entirety. IN NO EVENT DOES VHS PROVIDE ANY WARRANTY OR REPRESENTATIONS WITH RESPECT TO ANY THIRD PARTY HARDWARE OR SOFTWARE WITH WHICH THE CONSIGNPRO PRODUCT IS DESIGNED TO BE USED, AND VHS DISCLAIMS ALL LIABILITY WITH RESPECT TO ANY FAILURES THEREOF.

**10. LIMITATION OF LIABILITY.** Notwithstanding any damages that you might incur, the entire liability of VHS and any of its suppliers under any provision of this EULA and your exclusive remedy for all of the foregoing shall be limited to the greater of the amount actually paid by you for the ConsignPro Product or US\$1000.00. **TO THE MAXIMUM EXTENT PERMITTED BY APPLICABLE LAW, IN NO EVENT SHALL VHS OR ITS SUPPLIERS BE LIABLE FOR ANY SPECIAL, INCIDENTAL, INDIRECT, OR CONSEQUENTIAL DAMAGES WHATSOEVER (INCLUDING, BUT NOT LIMITED TO, DAMAGES FOR LOSS OF PROFITS, FOR LOSS OF DATA OR OTHER INFORMATION, FOR BUSINESS INTERRUPTION, FOR PERSONAL INJURY, FOR LOSS OF PRIVACY ARISING OUT OF OR IN ANY WAY RELATED TO THE USE OF OR INABILITY TO USE CONSIGNPRO, OR OTHERWISE IN CONNECTION WITH ANY PROVISION OF THIS EULA), EVEN IF VHS OR ANY SUPPLIER HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES AND EVEN IF THE REMEDY FAILS OF ITS ESSENTIAL PURPOSE.** Some states/jurisdictions do not allow the exclusion or limitation of incidental or consequential damages, so the above limitation or exclusion may not apply to you.

**11. COMPLIANCE WITH EXPORT LAWS.** You shall comply with all laws and regulations of the United States and other countries ("Export Laws") to ensure that the Software Product is

not (1) exported, directly or indirectly, in violation of Export Laws, or (2) used for any purpose prohibited by Export Laws, including, without limitation, nuclear, chemical, or biological weapons proliferation.

**13. CAPACITY AND AUTHORITY TO CONTRACT.** You represent that you are of the legal age of majority in your state, province jurisdiction of residence and, if applicable, you are duly authorized by your employer to enter into this contract.

**14. APPLICABLE LAW.** This EULA is governed by the laws of the United States of America (USA) exclusive of conflict of law provisions and you attorney to the jurisdiction of the courts of the USA with respect to any proceedings arising from this EULA. The parties hereby agree that this Agreement is not governed by the United Nations Convention on Contracts for the International Sale of Goods.

**15. ENTIRE AGREEMENT.** This EULA (including any addendum or amendment to this EULA which is included with the ConsignPro Product) is the entire agreement between you and VHS relating to ConsignPro and it supersedes all prior or contemporaneous oral or written communications, proposals and representations with respect to ConsignPro or any other subject matter covered by this EULA. To the extent the terms of any VHS policies or programs for support services conflict with the terms of this EULA, the terms of this EULA shall control. In the event of a conflict between the English and any non-English versions of this EULA, the English version shall govern. If any provision of this EULA is held by a court of competent jurisdiction to be contrary to law, such provision will be changed and interpreted so as to best accomplish the objectives of the original provision to the fullest extent allowed by law and the remaining provision of the EULA will remain in force and effect.

**16. NON-DISPARAGEMENT.** You agree not, in any public communication of any kind, including but not limited to, social media sites, software review sites, or any communication with current or prospective customers of Visual Horizons Software to criticize, ridicule, make any derogatory or disparaging statements about Visual Horizons Software, “ConsignPro” software, or any employees or directors of Visual Horizons Software. In addition, you agree that the following liquidated damage is accepted by you as fair and reasonable and would not act as a penalty: 1) three thousand five hundred dollars (\$3,500) for each proven incidence of disparagement. It is acknowledged by you that you understand and fully accept the above policy, the reasonable liquidated damage determinations, and the terms specified in this non-disparagement clause. Your understanding includes that this clause is a material term of this EULA, that you, the Purchaser, have available the opportunity to use Arbitration to settle and resolve any disputes with Visual Horizons Software, and that your failure to accept the terms and conditions of this clause would result in Visual Horizons Software refusing to license your use of “ConsignPro”.
